Call to Order

The meeting was called to order by Rich Myers at 12:08 p.m.

Approval of Minutes

The minutes from January 29, 2025 regular meeting, minutes and the special meeting on March 3, 2025 were reviewed. Kenny Hale made a motion to approve the minutes. Sara Dungan seconded the motion. Motion passed unanimously.

New Business

CCAB Public Meeting Plan per HEA 1167- Brian Foley informed the board that starting this meeting, April 30, 2025, Community Corrections Advisory Board will be live streamed and

recorded. The minutes, live stream recording, and agendas will be uploaded to the Morgan County website and available to the public.

2025/2026 JCC Grant Approval- Brian Foley updated the board on the FY 25/26 Juvenile Community Corrections Grant Approval. The total Grant Approval amount is \$92,851.00 which will start July 1, 2025.

2023/2024 JCC Grant Financial Audit Results- Brian Foley updated the board on the recent JCC Grant Financial Audit that was completed early March 2025. There were no findings in the audit.

SEA 9 JRAC 1st Quarter Electronic Monitoring - Brian Foley presented the board with the 1st Quarter Electronic Monitoring report which included 24 Adults and 1 Juvenile. This report was previously approved by the local JRAC team.

2025 1st Quarter Pretrial Supervision Report- Miranda Beauchamp presented the 1st Quarter Pretrial Supervision Report with a total of 96 assessments and 57% successful completion. Miranda Beauchamp noted the assessments and successful completion rate are very similar to previous pretrial supervision reports.

Local JRAC Team Update- Miranda Beauchamp updated the board that the Local JRAC team continues to meet monthly and to review local data. The JRAC current project is SIM Mapping workshop with the state to take place in September 2025.

2026 CC and Jail Treatment Grant Funding- Brian Foley advised the Board that it appears that IDOC Community Corrections grant funding will be reduced by 7 million dollars statewide in 2026. Brian stated the local effect of this is not yet known. Brian stated he will discuss budget options with the Board of Judges in case 2026 funding is reduced.

Community Supervision Officer- Brian Foley advised the Board that one of the Community Supervision Officers recently resigned and the position is currently posted and advertised.
