

**ORDINANCE NO. 2025- 1D**  
**AN ORDINANCE OF THE MORGAN COUNTY, INDIANA COUNCIL**  
**DIRECTING SUPPLEMENTAL TAX DISTRIBUTION TO BE FIRST USED**  
**TO LOWER THE COUNTY'S LEVY FREEZE TAX RATE**

**WHEREAS**, Morgan County, Indiana (the "County") is a municipality organized and existing entity under the provisions of Ind. Code § 36-2-2 *et.-seq.*;

**WHEREAS**, under Ind. Code § 36-2-2-1 the Morgan County Commissioners ("Commissioners") serve together as the Executive of the County (the "Executive"); and

**WHEREAS**, the Morgan County Council ("Council") serves as the fiscal body of the County and as the adopting body under relevant Indiana code for purposes relevant to this Resolution; and

**WHEREAS**, the County currently has a levy tax rate freeze;

**WHEREAS**, Indiana Code § 6-3.5-9-15 outlines that the State budget agency shall make a supplemental distribution to the County in certain circumstances;

**WHEREAS**, Indiana Code § 6-3.5-9-15 also provides, along with Ind. Code § 6-3.5-11-1, that the County may adopt a Resolution to provide that the supplemental distribution shall first be used to lower the County's levy freeze tax rate.

**NOW, THEREFORE, BE IT ORDAINED BY THE** Morgan County Council as follows:

**Section 1.** The foregoing recitals are fully incorporated herein by reference.

**Section 2.** Any supplemental distribution that may be determined under Ind. Code § 6-3.5-9-15(d)(4) to be attributed to the County shall first be used to lower the County's levy freeze tax rate.

**Section 3.** For the avoidance of doubt, all appropriate steps shall be taken to incorporate the May 2025 supplemental distribution already received by the County toward lowering the County's levy freeze tax rate.

**Section 4.** All prior Resolutions or parts thereof inconsistent with any provision of this Ordinance are hereby repealed.

**Section 5.** If any portion of this Resolution is for any reason declared to be unconstitutional or invalid, such decision shall not affect the validity of the remaining portions of this Resolution so long as enforcement of the same can be given the same effect.

Section 6. This Resolution shall be in full force and effect from and after its passage and signing by the Morgan County Council.
