

ORDINANCE NO. 2025-15

AN ORDINANCE ESTABLISHING FEES  
FOR THE MORGAN COUNTY HEALTH DEPARTMENT

WHEREAS, the Board of Commissioners of Morgan County are the executive and legislative body of Morgan County and have authority to establish and collect fees for services provided by Morgan County;

WHEREAS, this Ordinance amends and replaces the fee schedule contained in Ordinance 2019-3;

WHEREAS, the Morgan County Board of Health has approved and passed the following Ordinance in all respects and recommends its adoption by the Board of Commissioners.

Be it therefore ordained by the Board of Commissioners of Morgan County that:

1. The fee schedule in Ordinance 2019-3 shall be amended and replaced by the following fee schedule:



All of which is ordained this 3<sup>rd</sup> day of November 2025.


