5. Public Comment: No public comment.

<u>Waverly Sewer Update:</u> Per Brian Bullock, he provided a supplemental disbursement grant for the asset management plan. This document was completed by BLN and previously billed. The money came out of the traditional SRF funds instead of the supplemental (grant) funds. In order to move this money back, SRF requested this document be submitted. It will not require board action because the invoice has already been approved. This will free up \$10,000 that can be used or tuned back in on the loan.

Manns shared sewer easements were not recorded throughout the RMR property. She presented an email proposal from BLN for an amount not to exceed \$2,500 to record the easements and plat for the property. Commissioner Pipkin made the motion to approve the proposal as presented. Commissioner Shields seconded the motion, which carried 4-0.

Manns shared members of the Commission have been working with the Regional Sewer District and the County Commissioners to discuss how best to work with geographical partners regarding the Waverly Wastewater Treatment Plant. There are meetings scheduled with Johnson County and Bargersville officials later in May to discuss those efforts.

6. Legal Update:

a. Attorney Steuerwald shared Barnes & Thornburg are working on a memo regarding the legislative updates that occurred during session. That will be provided once it's available.

7. Economic Development Update:

a. Manns shared that she does anticipate in 2023 a TIF update will need to take place.

- 8. Other Business: Commissioner Hale was in attendance and provided an update on Waverly Park.
- 9. Adjournment: Motion to adjourn received a second and was approved 4-0.
