PRAYER (*Vickie Kivett*)

2024 Budget Adoption – Monroe Township Fire District

Chief Chris Mills stated that there were no real changes to the budget; the corrections were made for Gateway for DLGF. Vickie Kivett made a motion to approve the \$515,472 2024 budget for Monroe Township Fire District with a tax rate of 0.1402. Motion seconded by Troy Sprinkle. Motion carried 6-0. (Jason Maxwell was out of the room.)

Ordinance #2023-24 – Modification of Local Income Tax Rates

Kim Merideth stated that the public hearing for the changes to the Local Income Tax (LIT) rate was held at the previous meeting. The ordinance keeps the same rate of 2.72%, but changes the allocation rates as follows:

- Certified Shares 1.218% to 1.158%
- Public Safety .30% to .32%
- Economic Development .20% to .20%
- Property Tax Relief 1.002% to 1.002%
- Correctional or Rehabilitation Facilities 0.0% to .04%

Melissa Greene made a motion to approve the ordinance. Motion seconded by Troy Sprinkle. Motion carried 6-0. (Jason Maxwell was out of the room.)
