


Under Indiana Code 36-8-14-2


BE IT ORDAINED/RESOLVED by the Morgan County Commissioners of Morgan,
County, Indiana that a need now exists for the establishment of a Cumulative
Special Fire Fund for the following purposes: For all uses as set out in Indiana Code 36-8-14.

BE IT FURTHER ORDAINED/RESOLVED that this Board will adhere to the provisions of
Indiana Code 36-8-14. The proposed fund will not exceed \$ 0.0333 on each
\$100 of assessed valuation. Said tax rate will be levied beginning with taxes for 2024 payable
2025.

BE IT FURTHER ORDAINED/RESOLVED that a certified copy of this ordinance/resolution
shall be submitted to the Department of Local Government Finance of the State of Indiana as
provided by law. The tax rate for this Fund is subject to certification by the Department of Local
Government Finance.

APPENDIX B
NOTICE TO TAXPAYERS OF HEARING ON PROPOSED CUMULATIVE
Special Cumulative Fire FUND

Notice is hereby given to the taxpayers of Harrison Fire Protection District,
Morgan, County, Indiana, that the Morgan County Commissioners

will consider at the Lucille Sadler Room of the Morgan County Administration Building
at 9:30 o'clock am on March 4th, 2024, the establishment of

a Cumulative Special Fire Fund under the provisions of
Indiana Code 36-8-14-2 for the purposes as follows: For all uses as set out in
Indiana Code 36-8-14.

The tax will be levied on all taxable real and personal property within the taxing district and will not exceed \$0.0333 per \$100 of assessed valuation. The proposed fund will be levied beginning with taxes due and payable in the year 2025. Taxpayers appearing at such hearing shall have the right to be heard thereon. The proposed tax rate for the Cumulative Special Fire Fund is subject to certification by the Department of Local Government Finance.

Within 30 days after the date of the adoption of the cumulative fund by the Morgan County Commissioners, the Harrison Fire Protection District will publish a Notice of Adoption.

Upon publication of the Notice of Adoption, 25 or more taxpayers in the taxing district may file a petition with the County Auditor not later than noon 30 days after the publication of the Notice of Adoption setting forth their objections to the proposed fund.

NOTICE OF ADOPTION

To the taxpayers of Harrison Fire Protection District, Indiana.

You are hereby notified that on march 4, 2024, Harrison Fire Protection District,
Morgan County,

Indiana, pursuant to notice heretofore given, and under and by virtue of IC 36-8-14,

duly adopted a plan whereby a Cumulative Special Fire Fund was

established to provide for the following: For all uses as set out in Indiana Code 36-8-14

The fund will be provided for by a property tax rate of \$ 0.0333 per one hundred

dollars (\$100.00) of taxable real and personal property within the taxing unit beginning in 2024 payable 2025 and thereafter, continuing until reduced or rescinded.

25 or more taxpayers in the taxing unit who will be affected by the tax rate and corresponding levy may file a petition with the Morgan County Auditor not later than noon 30 days after the publication of this Notice setting forth their objections to the proposed cumulative fund. Upon the filing of the petition, the County Auditor shall immediately certify the same to the Department of Local Government Finance, at which point the Department will fix a date for and conduct a public hearing on the proposed cumulative fund before issuing its approval, disapproval, or modification thereof.
