

ORDINANCE NO. 2024-17

AN ORDINANCE AMENDING THE UNIFORM FEE SCHEDULE FOR THE MORGAN COUNTY DRAINAGE BOARD

WHEAREAS, the Morgan County Drainage Board (“Drainage Board” and the Morgan County Board of Commissioners have previously established a “Uniform Fee Schedule” by Ordinance, codified as Ordinance 7-3-6.1;

WHEAREAS, after review and study, the Morgan County Surveyor has recommended several changes and increases in the Uniform Fee Schedule to the Drainage Board and the Commissioners;

WHEAREAS, the fees imposed by the Drainage Board are reasonably related to the reasonable and just rates and charges for the services provided by the Drainage Board, including investigation and review of drainage plans and specifications for subdivisions and other development; and,


WHEAREAS, after due consideration, the Drainage Board and the Commissioners desire to amend the Uniform Fee Schedule for the Drainage Board.

NOW THEREFORE, BE IT ORDAINED by the Morgan County Drainage Board and the Board of Commissioners of Morgan County, Indiana, as follows:

1. The current Morgan County Drainage Board Uniform Fee Schedule is repealed and replaced by the fee schedule attached hereto and made a part hereof as Exhibit “A”.
2. All fees imposed by this Ordinance shall be collected by the Morgan County Surveyor and/or the Board of Commissioners, on behalf of the Morgan County Drainage Board. The fees collected under the Ordinance shall be deposited into the Morgan County General Fund.
3. This Ordinance repeals and replaces Ordinance 7-3-6.1.
4. This Ordinance shall be effective upon passage and publication, as by law required.





I. Subdivision

A.	Minor Subdivision	
1.	Primary & Secondary	\$250.00 (Includes review fee)
B.	Major Subdivision (with Post Construction BMP'S)

C.	Revision (Change to an Approved Plat) (Not recorded)	\$250.00

II. Planned Unit Development

A.	Principal	\$1300.00 + \$10.00 (lot/acre/unit)

VI. Individual Residence and Farms

A.	Regulated Drain Outlet Permit	\$200.00 (per outlet)
B.	Regulated Drain Crossing Permit	\$250.00 (per crossing)
C.	Regulated Drain Encroachment Permit	\$250.00 (per encroachment)

VII. Utilities

A.	Regulated Drain Crossing Permit	\$250.00 (per crossing)
B.	Regulated Drain Encroachment Permit	\$.25 per ft. (Min. \$ 250.00)

VIII. Other

A.	Removal of Obstruction Application	\$250.00

(NOTE): All fees in this section can be waived or modified by the Morgan County Surveyor.

IX. Engineering Review Fees

All engineering projects will require a review fee above and beyond the application fee(s). The review fee shall equate to the contract rate of the reviewing engineer, to be billed monthly. This fee shall be paid to the Morgan County Treasurer and shall be paid in full before any project approval is given.

X. All fees paid will be deposited in Morgan County's General Fund; and all remaining monies from Subdivision Review Fees Account # 432-3000 will be deposited into the Morgan County's General Fund.
