

ORDINANCE 2024-23

**An Ordinance to Establish Donation Fund Accounts**

**WHEREAS**, the Morgan County Sheriff's Office at times receives offers of donations for the Morgan County SWAT Program and the Morgan County Sheriff's Office;

**WHEREAS**, the Morgan County Sheriff's Office currently has no means to receive and account for the receipt of such donations;

**WHEREAS**, the Morgan County Sheriff's Office has requested the creation of fund accounts to receive the aforementioned donations; and

**WHEREAS**, it is the desire of the Morgan County Board of Commissioners to facilitate the receipt and accounting for donations to the Morgan County SWAT Program and Morgan County Sheriff's Office.

**NOW, THEREFORE, BE IT ORDAINED AND ESTABLISHED BY THE MORGAN COUNTY BOARD OF COMMISSIONERS:**

Section 1. The County Sheriff's Department "SWAT Fund" is hereby established and shall be implemented as follows:

- A. All funds received as donations shall be deposited with the County Treasurer and accounted for to the County Auditor.
- B. Disbursements shall be made from this fund in accordance with standard appropriation practices.
- C. The Morgan County Sheriff's Department shall be notified of the passage of this Ordinance and shall deposit any donations to the Morgan County SWAT Program to the County Treasurer for deposit in this fund.

Section 2. The "Morgan County Sheriff's Office Fund" is hereby established and shall be implemented as follows:

- A. All funds received as donations shall be deposited with the County Treasurer and accounted for to the County Auditor.
- B. Disbursements shall be made from this fund in accordance with standard appropriation practices.
- C. The Morgan County Sheriff's Department shall be notified of the passage of this Ordinance and shall deposit any donations to the Morgan County Sheriff's Office Fund to the County Treasurer for deposit in this fund.


Section 3. This Ordinance shall become effective immediately upon passage but applies retroactively with respect to any funds currently held and to be deposited in accordance with the above.


