Attorney Youngs continues communication with involved parties regarding illegal dumping costs.

The Memorandum of Understanding between MCRSD, Morgan County Commissioners, Morgan County RDC, and Town of Bargersville has been executed and copies sent to all.

The paving bids for asphalt to surround the plant have been taken under advisement.
