Approval of Minutes

The minutes from the July 30, 2025 regular meeting and the special meeting minutes from August 11, 2025 were reviewed. Joni Bishop made a motion to approve the minutes. Sara Dungan seconded the motion. Motion passed unanimously.

New Business

2026 Meeting Dates- Brian Foley presented the board with proposed 2026 meeting dates. Brian Williams made a motion to approve the 2026 meeting dates. Sara Dungan seconded the motion. Motion passed unanimously.

SEA 9 JRAC 3rd Quarter Electronic Monitoring - Brian Foley presented the board with the 3rd Quarter Electronic Monitoring report which included 36 Adults and 3 Juveniles. This report was previously approved by the local JRAC team.

2025 3rd Quarter Pretrial Supervision Report- Miranda Beauchamp reviewed the 3rd Quarter Pretrial Supervision Report with a total of 94 assessments and 165 currently on active Pretrial Supervision. Miranda Beauchamp noted new criteria starting July 1st for violent offenders.

Home Detention Daily Fee Rate Increase Approval- Brian Foley informed the board of a recent study done from surrounding agencies regarding daily fees for Home Detention which showed Morgan County's current fees as lower than most other counties. Brian Foley submitted for approval the increase from \$10/day minimum to \$15/day for Electronic Monitoring. Brian Williams made a motion to approve the increase. Joni Bishop seconded the motion. Motion passed unanimously.

Local JRAC Team Update- Miranda Beauchamp updated the board that the Local JRAC team starting in 2026 will meet bi-monthly. Local JRAC held a SIM mapping project in September with over 50 attendees from different agencies.
