**ORDER GRANTING TRANSFER OF
ASSETS WITHOUT ADMINISTRATION (SMALL ESTATE)**

The Court finds that:

The value of decedent's gross probate estate, less liens and encumbrances, does not exceed the sum of:

- (1) Fifty thousand dollars \$50,000.00 (if decedent died prior to July 1, 2022) or One Hundred thousand dollars \$100,000.00 (if decedent died after July 1, 2022);
- (2) The cost and expenses of administration; and
- (3) Reasonable funeral expenses.

IT IS THEREFORE ORDERED that _____, Petitioner, without giving notice to creditors, may immediately disburse and distribute the estate to the persons entitled to it and file a closing statement as provided in IC 29-1-8-4.
