

ORDINANCE No. 2023 - 27

ORDINANCE APPROVING DISPOSITION OF PERSONAL PROPERTY

WHEREAS, the Board of Commissioners of Morgan County, Indiana ("Commissioners") is the executive and legislative body for Morgan County, I.C. 36-1-2-5 and I.C. 36-1-2-9;

WHEREAS, I.C. § 5-22-22 provides authority for the disposition of surplus personal property by a government body and procedures to administer the same;

WHEREAS, in accordance with I.C. § 5-22-22-4.7, I.C. § 5-22-22-5 and I.C. § 5-22-22-6, require personal property owned by the County to be sold at public sale in instances in which the property being sold is one (1) item that has a value of One Thousand Dollars (\$1000.00) or more, or more than one (1) item with a total value of Five Thousand Dollars (\$5000.00) or more;

WHEREAS, said public sale must be advertised in accordance with I.C. § 5-3-1, sealed bids submitted prior to the date of the sale must be accepted, and all sales shall be made to the highest responsible bidder;

WHEREAS, I.C. § 5-22-22-7 specifically instructs that recyclable property owned by the County (1) may be recycled; and (2) has been collected in conjunction with a recycling program; the purchasing agency may, without advertising, sell the property at a public or private sale or transfer the property;

WHEREAS, I.C. § 5-22-22-8 specifically instructs with regard to worthless property that if the property is worthless, it may be demolished or junked, and defines worthless property as that which has no market value or the market value is less than the estimated costs of the sale and transportation of the property;

WHEREAS, the County is in possession and ownership of such personal property that is no longer needed or used, but has an aggregate value of more than Five Thousand Dollars (\$5000.00);

WHEREAS, the County is in possession and ownership of such recyclable property;

WHEREAS, the County is in possession and ownership of such other property that is outdated, unusable, in a state of disrepair or other such condition that meets the foregoing definition of worthless property; and


WHEREAS, the County no longer needs or uses the foregoing property and incurs expense to retain and store said property.

NOW THEREFORE, EFFECTIVE IMMEDIATELY, it is hereby ordained by the Board of Commissioners of Morgan County, Indiana that:

The following items of worthless personal property owned by Morgan County shall be disposed of in accordance with § 5-22-22-8: See attached Exhibit C.




