- B. Commissioner Elliott presented the opportunity of joining the Redevelopment Association of Indiana (RAI) to the Commission. Commissioner Snyder made the motion to move forward with the RAI membership as presented. Commissioner Merideth seconded the motion, which carried 5-0.
- C. Auditor Bastin share the Commission received a ballot for the Johnson County REMC. A collective decision was made not to cast a vote.
