## MORGAN COUNTY REDEVELOPMENT COMMISSION June 14, 2021— Meeting Minutes

I. <u>Roll Call:</u> On the call of the roll the following Commissioners were shown to be present: Kim Merideth, Troy Sprinkle and Daniel Elliott. Carole Snyder, Ralph Foley and Dr. Jake Allen were absent.

Commissioner Elliott called the meeting to order and led the Commission in the pledge.

- II. <u>Reading and Approval of the Minutes:</u> Commission meeting minutes from May 10, 2021 were reviewed. Commissioner Merideth made the motion to approve minutes as presented. Commissioner Sprinkle seconded the motion, which carried 3-0.

- c. Sewer lines and Lift Station The majority of the punch list is complete. Reed still has to go back and address a couple of customer complaints regarding the final grading and seeding of their yards.
- d. Sewer Extension south of school to Central Avenue Permits applications have been submitted and we are waiting on their final approvals as well as the final price from the contractor.
- e. Closeout Documents BLN is currently working on compiling all these documents and will submit an electronic file once completed.
- B. Platting Manns noted that there was a couple of issues with the plat as it was provided. The biggest issue was the lack of deed of dedication, which Attorney VanLeeuwen was working through. Once that was completed, Manns would get the plat recorded.
- C. Legal Update
  - a. Attorney VanLeeuwen was not present and there was no update.
- D. Economic Development Update
  - **a.** Manns did share the progress on the One Western Region partnership with Hendricks County.
  - **b.** Manns met with Brian Bilger, Executive Director of the Hendricks County Economic Development Partnership.
  - **c.** Manns participated on a panel for Hendricks County Leadership on the SR39/I-70 Corridor.
  - d. Josh Messmer, Laura Parker and Manns met to discuss development throughout the county moving forward. Messmer mentioned working through the READI initiative and ARPA monies.

## VI. Other Business

- A. Waverly Park Update Commissioner Hale presented an update on Waverly Park. He presented quotes regarding the milling and sealing of the asphalt trail as follows:

  - b. Midwest Paving No submittal
  - c. Wallace \$23,904.32
  - d. Mann Paving \$28,605.00

Commissioner Sprinkle made the motion to approve the low bid of Wallace Construction in the amount of \$23,904.32. Commissioner Merideth seconded the motion, which carried 3-0.

Commissioner Elliott presented Commissioner Hale with a plaque as a thank you for his hard work and dedication to the Waverly Wastewater Treatment Plant.

- B. Manns presented Resolution 2021-001 regarding the pass-through of assessed value for 2021 Pay 2022 along with corresponding worksheets. The Resolution does not allow for excess pass through of assessed value. Commissioner Merideth made the motion to approve the resolution as presented. Commissioner Sprinkle seconded the motion, which carried 3-0.
