V. Reports To The Redevelopment Commission

- A. Waverly Sewer Update Manns provided update per Bullock:
 - a. The sewer extension along Waverly Road to Central Avenue is now complete including pavement restoration. Reed is still supposed to be installing two service valve vaults along the new force main. We are waiting on signed easements before they can do that. Other than that, they just have a couple yards to finish cleaning up. We have also been working with Aqua and Graves to address some warranty items at the plant. Repairs have been made to the chemical feed pump and the mixers.
 - b. Commissioner Elliott noted the project came in under budget and there could be potential to reallocate those funds within the project to make enhancements.

- B. Platting Update Attorney VanLeeuwen worked with Commissioner Foley on the Deed of Dedication. It ensures the Commission will maintain the road. It was requested that Attorney VanLeeuwen get a contract for snow removal from Wallace Construction.
- C. Legal Update
 - a. No legal update.
- D. Economic Development Update
 - a. Manns noted her work with Baker Tilly on the Annual Report and coordination with invitations to the underlying taxing units. She also noted the ongoing work with the One Western Partnership and the additional need for legal assistance from Lisa Lee of Ice Miller.

- A. Waverly Park Update County Commissioner Hale provided a Waverly Park update.
- B. Manns shared she will be going before the County Commissioners on September 20th to discuss broadband.
