  - a. BLN is continuing to work with Aqua and Graves on a couple of warranty issues at the plant. They also have started the PER revisions approved by the RDC at the request of the Regional Sewer District at last month's meeting.
- B. Legal Update No update at this time.
- C. Economic Development Update
  - **a.** Broadband Manns requested the Commissioners each review the broadband link provided in their packet regarding the survey that will go live next week. The invoice for Banning in this month's financials is for work associated with the survey and mapping components.
  - **b.** The Commission is still awaiting infrastructure numbers from Raindrop, LLC in order to further negotiate the Westpoint TIF.

- c. Manns shared she met with Senator Bray and Josh Messmer regarding HB 1002 and taking away personal property. That language was stripped from the bill but language was added regarding sunsetting food and beverage tax. Questions were asked about SB 361 creating Innovative Development Districts which did pass.
- **d.** Waverly Commissioner Elliott noted there is interest from the private sector to purchase parts of the area owned by the Commission in Waverly. Commissioner Merideth made the motion to approve attaining two appraisals. Commissioner Pipkin seconded the motion which carried 4-0.
- D. Waverly Commissioner Elliott noted that County Commissioner Hale is focused on the cabin currently.
- VI. Adjournment: Motion to adjourn received a second and was approved 4-0.
