RESOLUTION 2022-

PRELIMINARY RESOLUTION SUPPORTING THE DISSOLUTION OF THE MORGAN COUNTY SOLID WASTE MANAGEMENT DISTRICT

WHEREAS, the Morgan County Council (hereinafter "Council") is the fiscal body for Morgan County, Indiana (hereinafter "County"); and,

WHEREAS, in discharging its duties, which include promulgating an annual budget, the Council is continuously in search of ways to improve the efficiency and cost-effectiveness of the expenditure of County resources; and,

WHEREAS, within Title III of the Morgan County Code of Ordinances concerning Administration, there is a certain Chapter 32 concerning Boundaries and Districts, and therein a certain Section 8 that established the Morgan County Solid Waste Management District (hereinafter "MCSWD"), effective as of January 1, 2008; and,

WHEREAS, since the adoption of the above-referenced Ch. 32.08 of the Morgan County Code of Ordinance, I.C. § 13-21-3 has been amended by the Indiana General Assembly by authorizing counties to dissolve their local Solid Waste Management District; and,

WHEREAS, the Council believes additional efficiencies, savings, and oversight can be gained by the dissolution of the MCSWD; and,

WHEREAS, it is not believed that the dissolution of the MCSWD will adversely affect the General Fund of the County, nor any other source of funding for the County.

NOW THEREFORE, BE IT RESOLVED that the Morgan County Council supports moving forward with the dissolution of the Morgan County Solid Waste Management District and encourages the Morgan County Board of Commissioners to take such actions required by statute to properly effectuate such dissolution.
