# Lake Ditch / ER Robards Tributary Quotes

Terry Brock handed out copies of the quotes that were received for maintenance of the Lake Ditch tributaries. Mr. Brock also issued a letter recommending which quote to accept. Stafford was the lowest bidder on all the tributaries, but only wanted four because he did not think he could finish all eight by April, and voluntarily withdrew the bids on the other four. Wolf Excavating was the lowest bid on the remaining four. The quotes were as follows:
