DRAINAGE BOARD MEMBERS PRESENT WERE TERRY BROCK (Surveyor), NORMAN VOYLES (Commissioner), JEFF QUYLE (Commissioner), AND BRIAN GOSS (Commissioner).

DRAINAGE COMPLAINT - RON JOHNSON

Norman Voyles stated that there is water coming across the property of Mr. Ron Johnson. Mr. Voyles stated that he has been out to the property. Mr. Johnson was present and stated that Cinery repaired property that they tore up while repairing a pole, but all the straw and seed washed into his backyard. Mr. Johnson's property is located in Martinsville at 100 Hillview Drive by Shireman Estates. Mr. Johnson stated that they cut down the hump by the exit pipe. Jeff Quyle stated that since some of the water is coming from County ditches, he suggested that the County Highway Department put in a swale to take the water partway past. Brian Goss asked if Mr. Johnson would be willing to take the fence down and put it back up if it was in the way of equipment putting in a swale. Mr. Johnson stated that he would. Norman Voyles asked if it would be satisfactory if the Highway Department dug a shallow swale from the street to the west end of his fence. Mr. Voyles offered to go out with the Highway Department, with the Board's approval, to see if something could be done. Jeff Quyle made a motion to approve allowing Commissioner Voyles to work with the Highway Department to build a swale to try to alleviate the county ditch water that is going across Mr. Johnson's property. Seconded by Brian Goss. Motion carried 3-0.

DRAINAGE COMPLAINT - DAVE TROUT

Terry Brock stated that he talked to Ross Drapalik and he was going to look at Mr. Trout's property again.

MORGAN TRAILS - SECTION 4 (John Drapalik)

Terry Brock stated that they changed drainage and it is not prepared yet.


SARTOR DITCH

Terry Brock stated that he would like permission to request bids for Sartor Ditch within the cemetery by the fairgrounds. Mr. Brock stated that the ditch is snaking through the cemetery and needs to be taken care of before it gets into gravesites. Jeff Quyle made a motion to request the County Surveyor to take bids to work on Sartor Ditch in the Hilldale Cemetery. Seconded by Brian Goss. Motion carried 3-0.


