Beginning at a point on the east line of said quarter-quarter, 716.5 feet south of the northeast corner thereof; thence continuing south on said east line 50.0 feet to a pipe; thence deflecting right 89 degrees 20 minutes and running westerly 250.0 feet; thence deflecting left 89 degrees 20 minutes and running southerly, parallel with the east line of said quarterquarter, 150.0 feet; thence deflecting right 89 degrees 20 minutes and running westerly 250.0 feet; thence deflecting right 90 degrees 40 minutes and running northerly, parallel with the east line of sald quarter-quarter, 350.0 feet; thence deflecting right 89 degrees 20 minutes and running easterly 250.0 feet; thence deflecting right 90 degrees 40 minutes and running southerly, parallel with the east line of said quarterm quarter, 150.0 feet; thence deflecting left 90 degrees 40 minutes and running easterly 250.0 feet to the place of beginning, containing 2.3 acres, more or less. Beginning at a pipe on the east line of said quarter-quarter, 235.0 feet south of the Northeast corner thereof; thence south on said east line 35.0 feet to the northeast corner of Godsey Subdivision (First); thence deflecting right 85 degrees 45 minutes and running westerly on the north line of said subdivision 250.0 feet; thence deflecting left 85 degrees 45 minutes and running south, parallel with the east line of said quarter-quarter, 255.0 feet; thence deflecting right 85 degrees 45 minutes and running westerly on the north line of said subdivision 224.0 feet to the northwest corner of Lot \#2 in said subdivision; thence deflecting right 94 degrees 15 minutes and running north, parallel with the east line of said quarter-quarter, 290.0 feet to a pipe; thence deflecting right 85 degrees 45 minutes and running easterly 474.0 feet to the place of beginning, containing 1.692 acres, more or less.
