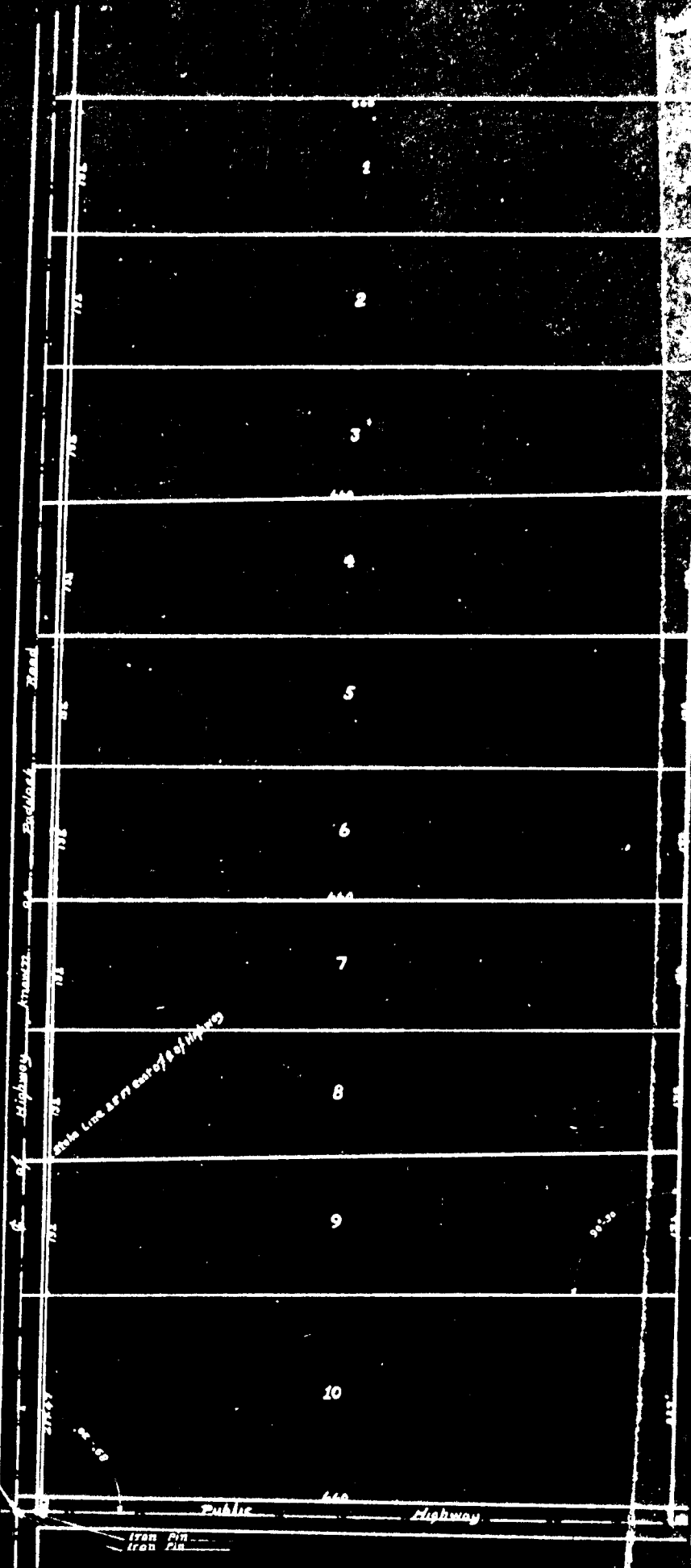

 Township 14 N. R. 2 E.

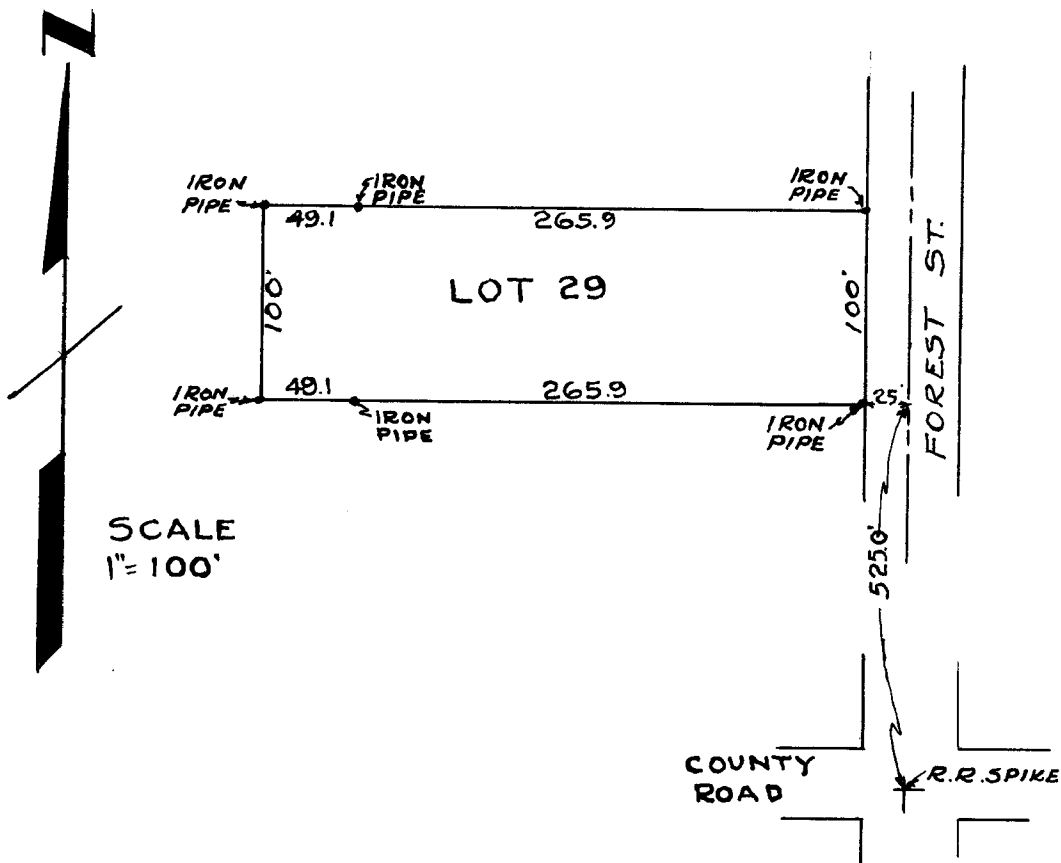

Beginning at a Stone at the Northwest corner of Section thirty five (35), township and range aforesaid, run thence southerly on the West line of said Northwest quarter a distance of eleven hundred and fifty six (1156.00) feet to the Northwest corner of the following described real estate and the **BEGINNING POINT OF THIS DESCRIPTION.**

From Said **BEGINNING POINT** continue thence southerly on the West line of said Northwest quarter a distance of one hundred eighty two (182.00) feet;

deflect 90 degrees and 54 minutes left and run thence easterly and parallel to the North line of said Northwest quarter a distance of four hundred seventy eight and seven-tenths (478.7) feet;

run thence northerly and parallel to the West line of said Northwest quarter a distance of one hundred eighty two (182.00) feet;

run thence westerly and parallel to said North line a distance of four hundred seventy eight and seven-tenths (478.7) feet to the place of beginning, containing two (2.00) acres, more or less, and **SUBJECT** to thirty (30.0) feet of even width off of and across the entire west end thereof, being the legal right-of-way of County Road running North and South.

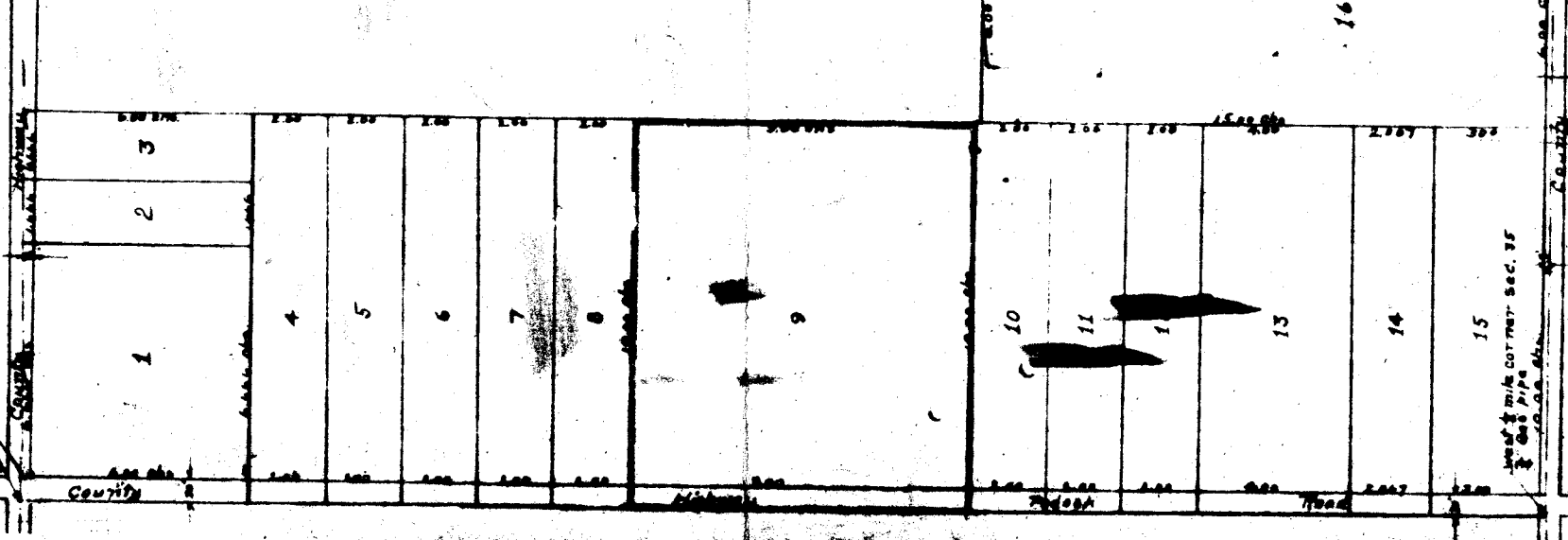

LEGAL DESCRIPTION:

A PART OF LOT NO. 1 OF THE SECOND PLAT OF FOREST G. MILLER'S SUBDIVISION OF A PART OF THE NORTHWEST QUARTER OF SECTION 35, TOWNSHIP 14 NORTH, RANGE 2 EAST OF MORGAN COUNTY, INDIANA, MORE DEFINITELY BOUNDED AND DESCRIBED AS FOLLOWS, TO WIT:
