DESCRIPTION.

This Addition is situated upon, and occupies, the following described tracts of land, to-wit: A part of the south-west quarter of section four (4), Township eleven, (11) North, Range one, (1) east of the second Principal Meridian of Indiana, bounded and described as follows: beginning on the east and west center line of said section four, (4) at the point where the extension south of the center line of Main Street, in the city of Martinsville, intersects said east and west center line of said section four, (4), and running thence west with said east and west center line 540.54 feet to a stone corner; thence south 512.90 feet to a stone corner; thence east parallel to the said east and west center line of said section 4, 561 feet to the extension, south, of the center line of Main street, aforesaid; thence north with the center line of Main street, extended, 512.9 feet to the place of beginning, containing 6.29 acres more or less; Also Out Lot numbered One, (1) in J. 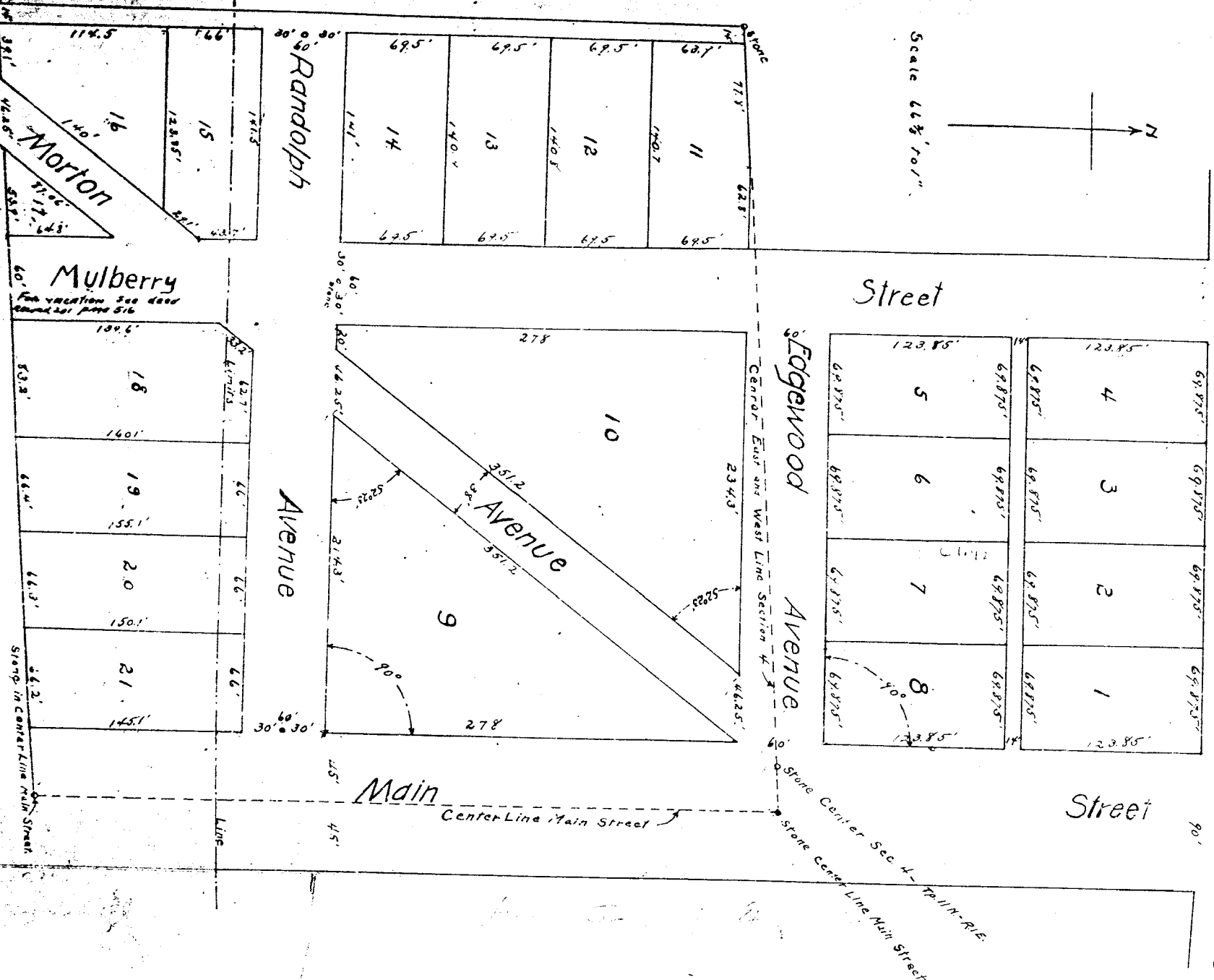
